Dinwiddie County Water Authority customers served by the Town of McKenney, and located outside the town limits, follow the water and sewer rate structure established by the Town of McKenney Town Council. Dinwiddie County Water Authority customers served by the County of Prince George, located along Johnson Road, follow the water and sewer rate structure established by the County of Prince George.

Dinwiddie County Water Authority customers served by residential sewer only in the Dinwiddie Village area shall pay a flat rate of \$24.97 with an annual increase of 4%.

Private sprinkler fees and private fire hydrant fees will increase 4% annually.

The Dinwiddie County Water Authority will review rates on an annual basis and make adjustments if necessary, through the public hearing process.

A public hearing will be held on Monday, June 10th at 1:00 at the Dinwiddie County Water Authority offices located at 23008 Airpark Dr, North Dinwiddie.
